GUIDELINES FOR COLLABORATIVE PROVISION OF POST SECONDARY AND TERTIARY EDUCATION

Institutions engaged in collaborative arrangements in which the Awarding Institution is a transnational/foreign institution are required to apply for recognition of the qualification by ACTT. There are three major criteria for the recognition of transnational/foreign qualifications in Trinidad and Tobago:

Criterion 1.0

A written and legally binding agreement or contract setting out in detail the rights and obligations of the parties identified as the Awarding Institution and the Partner Institution.

- 1.1 There exists a written and legally binding agreement or contract relating to the programme, signed by the heads of the Awarding Institution and the Partner Institution.*
- 1.2 The rights and obligations of the Awarding Institution and the Partner Institution are clearly stated in the agreement or contract.*
- 1.3 The respective responsibilities of the Awarding Institution and Partner Institution are clear, explicit and documented.*

Criterion 2.0

The Awarding Institution is responsible for the academic standards of all awards granted in its name.

- 2.1 Academic standards for the programme have been established by the Awarding Institution.*
- 2.2 The Awarding Institution has a system for the approval, monitoring and review of academic standards.*

- 2.3 The Awarding Institution is responsible for the teaching and learning process leading to the final award.*
- 2.4 The programme is delivered by faculty who are proficient in terms of qualifications, teaching, research (if relevant) and other professional experience so as to maintain academic standards.*
- 2.5 The Awarding Institution is responsible for the assessment of students and award of qualifications.*

Criterion 3.0

The Awarding Institution must be able to demonstrate that each programme provided through the partnership is comparable to a similar or identical programme in the country of origin.

- 3.1 The programme has admission requirements that are equivalent to those of the same or comparable programmes delivered by the Awarding Institution in its country of origin.*
- 3.2 The programme has an academic workload that is equivalent to that of comparable programmes in the Awarding Institution.*
- 3.3 The qualification provides graduates with the same access to further study as that provided to graduates of comparable programmes in the country of origin.*

If the programme offered in Trinidad and Tobago differs from the programme offered by the Awarding Institution in its country of origin, the Awarding Institution must provide a clear statement on the variation, the rationale for it and the consequences for the recognition of the qualification awarded. This may be cause for an in-depth evaluation of the programme by ACTT.
